- 1. Chartered Accountants with a minimum of four years standing in practice or in service are elle
- 2. University Lecturers/Professors with a minimum of five years teaching experience are eligible to
- 3. Persons above 60 years of age are not eligible for empanelment as examiner.
- 4. Brief description of nature of work (Professional or Teaching) handled and handling be attached.
- Copies of Mark sheets/Degree/Passing certificate/COP/ other relevant testimonials must be attached.
- 6. Persons who are undergoing any course of the Institute cannot seek empanelment.
- 7. All columns must be filled in or struck off if not applicable; else such incomplete application will be rejected.
- Student Bounty.com 8. Those whose applications were rejected earlier or rested/removed from the panel are not eligible to apply
- 9. The empanelment process would take considerable long time, say 4-6 months and no interim correspondence, in meantime, will be entertained.
