TEXT 1**Children born today will live to be 81**

Life expectancy in the UK has reached its highest level for men and women. Boys and girls could expect on average to live to 76.9 years and 81.3 years of age respectively. Men reaching 65 today can expect to live for another 16.9 years and women a further 19.7 years.

FIG. 1**Satisfaction with NHS hospitals and GPs in their area: 2004¹ Great Britain**


