**EQUALITY WATCHDOG CLEARS POLICE OF INSTITUTIONAL RACISM**

The chairman of the UK's Equalities and Human Rights Commission, Sir Trevor Phillips, said that the police should no longer be accused of 'institutional racism'. In a speech marking 10 years since the Macpherson Report on the Stephen Lawrence murder, Sir Trevor said that the UK and the police had changed massively. The accusation of institutionalised racism levelled against the Metropolitan Police by the Macpherson Report was no longer appropriate. The way the police dealt with issues such as racist murders had improved. He also said that Britain 'is by far the best place in Europe to live if you are not white', suggesting that the UK is now a much changed place, at ease with racial diversity – even if problems still remain.

**MINISTER OF JUSTICE PLANS ‘DUTIES OF BEHAVIOUR’ IN BILL OF RIGHTS**

The Justice Secretary, Jack Straw, proposed a new UK Bill of Rights and Duties that may include ‘duties of behaviour’ between fellow citizens that would be enforceable by judges. He said this was needed because people were selfishly claiming their rights without paying attention to the rights of others. Mr Straw said that people needed to be more aware of their responsibilities to others in society and that they should collaborate and compromise rather than just claim their own rights. A UK Bill of Rights and Duties would be in addition to the rights guaranteed by the European Convention on Human Rights and the European Court of Human Rights.
