OR

- 4 ‘The beginnings of the Hollywood studio system are evident in the production and distribution of early genre films.’ To what extent do you agree with this claim? [30]**

The impact of World War II on British Cinema (1939–45)

EITHER

- 5 How successful was the British Government in its use of cinema as a tool to help win the war? [30]**

OR

- 6 To what extent do you think British films of this period affected the ideas of audiences towards the war? [30]**

The rise of the blockbuster, format wars and multiplexes (1972–84)

EITHER

- 7 How much did the success of the 1970s ‘blockbusters’ impact on exhibition strategies used by cinema operators? [30]**

OR

- 8 To what extent was the use of home video linked to the decline of ‘fleapit’ cinemas in the UK? [30]**

**Developments in 21st Century Cinema and Film
(2000–present)**

EITHER

- 9 Discuss how institutions are using digital technologies in film distribution and exhibition to create new business opportunities. [30]**

OR

- 10 ‘The recent revival of 3D has proved to be a commercial failure.’ Discuss this view. [30]**
