Source A

Rwanda seeks investors, not donors, to become a high-tech hub

The International Monetary Fund (IMF) predicted that economic growth in Sub-Saharan Africa would average 6.1% in 2014, compared with 3.7% worldwide. Critics argue that this growth springs mostly from the sale of natural resources and that the gains have been shared between a few wealthy Africans and foreign corporations.

However, Rwanda may offer an alternative growth model. It aims to develop itself into an information-technology hub for the East African Community, a regional common market, and it is seeking investment rather than aid. The nation has wired itself with fibre optic cables, and last year the government signed a deal to build a 4G network that would cover 95% of the country. Small enterprise and crowdfunding (small investments from large numbers of ordinary people) are also crucial to this transformation. Rwanda's economy is growing on average 8% per year and development organisations such as the World Bank have praised the country's economic reforms.

Human rights groups are concerned about the country's repressive political policies. Yet the President's tight grip on power and rising living standards following his economic reforms do seem to have created stability – at least so far there has been no return to the genocide of 1994.

Source B

Interview with Mr Maina KIAI – UN Special Envoy on the rights to freedom of peaceful assembly and association

What is your advice for all young people who want to participate in the political decisions of a country through peaceful manifestations but have to face, sometimes, brutal police repression?

I don't think you can advise people to go out and get beaten. I think standing firm to the principle of a peaceful demonstration is crucial. Now, sometimes there's a price to pay for that, but I think that resisting the urge to be violent is a very important thing! It's not easy, you must say when you're being confronted with law enforcement officials who are armed and coming at you, it's easy for someone to say "please be peaceful". But what we've seen from people like Mahatma Gandhi or Martin Luther King is that yes, sometimes being peaceful can have a big impact even when the law enforcement are coming at you violently.

I think it is critical that youth engage in peaceful protest. I think it is the most important time of life because you get your ideas and your identity clear when you are young, and it is so important to be engaged at that age when you can, and when you can even run away – much easier than older people. I think it is an important time, and it is a good way to form a basis and a link to society and to idealism.

For me, the big thing is that we are seeing a world that's getting more and more conservative and the ideals of social change and progress and a fair and a just society are reducing and wilting away. That's got to be confronted by young people, who need to have ideals, who need to be reading as widely as possible and find the solidarity across nations, north, south, east and west.
