

**Source B****How a Bill becomes an Act****Source C****The Role of the House of Commons**

The House of Commons really has limited power at present. Decisions on major issues like the Iraq war and significant changes in economic policy are made in Number 10. The Whips ensure obedience. Even the ability of MPs to look after the interests of constituents and constituencies is becoming increasingly limited as the executive dominates the agenda of the Commons. Select Committees, set up to monitor government departments, often have their recommendations ignored.
