***Mark Scheme***

Mark schemes are prepared by the Principal Examiner and considered, together with the relevant questions, by a panel of subject teachers. This mark scheme includes any amendments made at the standardisation events which all examiners participate in and is the scheme which was used by them in this examination. The standardisation process ensures that the mark scheme covers the students' responses to questions and that every examiner understands and applies it in the same correct way. As preparation for standardisation each examiner analyses a number of students' scripts: alternative answers not already covered by the mark scheme are discussed and legislated for. If, after the standardisation process, examiners encounter unusual answers which have not been raised they are required to refer these to the Principal Examiner.

It must be stressed that a mark scheme is a working document, in many cases further developed and expanded on the basis of students' reactions to a particular paper. Assumptions about future mark schemes on the basis of one year's document should be avoided; whilst the guiding principles of assessment remain constant, details will change, depending on the content of a particular examination paper.

## Generic Introduction for A2

The A2 History specification is based on the assessment objectives laid down in QCA's GCE History subject criteria and published in the AQA specification booklet. These cover the skills, knowledge and understanding which are expected of A Level students. Most questions address more than one objective since a good historian must be able to combine a range of skills and knowledge. Consequently, the marking scheme which follows is a 'levels of response' scheme and assesses students' historical skills in the context of their knowledge and understanding of History.

The levels of response are a graduated recognition of how students have demonstrated their abilities in the Assessment Objectives. Students who predominantly address AO1(a) by writing narrative or description will perform at Level 1 or low Level 2 if some comment is included. Students who provide more explanation – (AO1(b), supported by the relevant selection of material, AO1(a)) – will perform at Level 2 or low Level 3 depending on their synoptic understanding and linkage of ideas. Students who provide explanation with evaluation, judgement and an awareness of historical interpretations will be addressing all 3 AOs (AO1(a); AO1(b); AO2(b)) and will have access to the higher mark ranges.

To obtain an award of Level 3 or higher, students will need to address the synoptic requirements of A Level. The open-ended essay questions set are, by nature, synoptic and encourage a range of argument. Differentiation between performance at Levels 3, 4, and 5 therefore depends on how a student's knowledge and understanding are combined and used to support an argument and the how that argument is communicated.

The mark scheme emphasises features which measure the extent to which a student has begun to *'think like a historian'* and show higher order skills. As indicated in the level criteria, students will show their historical understanding by:

- The way the requirements of the question are interpreted
- The quality of the arguments and the range/depth/type of material used in support
- The presentation of the answer (including the level of communication skills)
- The awareness and use of differing historical interpretations
- The degree of independent judgement and conceptual understanding shown

It is expected that A2 students will perform to the highest level possible for them and the requirements for Level 5, which demands the highest level of expertise have therefore been made deliberately challenging in order to identify the most able students.

#### **General Guidance for Examiners (to accompany Level Descriptors)**

---

##### **Deciding on a level and the award of marks within a level**

It is of vital importance that examiners familiarise themselves with the generic mark scheme and apply it consistently, as directed by the Principal Examiner, in order to facilitate comparability across options.

The indicative mark scheme for each paper is designed to illustrate some of the material that students might refer to (knowledge) and some of the approaches and ideas they might develop (skills). It is not, however, prescriptive and should only be used to exemplify the generic mark scheme.

When applying the generic mark scheme, examiners will constantly need to exercise judgement to decide which level fits an answer best. Few essays will display all the characteristics of a level, so deciding the most appropriate will always be the first task.

Each level has a range of marks and for an essay which has a strong correlation with the level descriptors the middle mark should be given. However, when an answer has some of the characteristics of the level above or below, or seems stronger or weaker on comparison with many other students' responses to the same question, the mark will need to be adjusted up or down.

When deciding on the mark within a level, the following criteria should be considered *in relation to the level descriptors*. Students should never be doubly penalised. If a student with poor communication skills has been placed in Level 2, he or she should not be moved to the bottom of the level on the basis of the poor quality of written communication. On the other hand, a student with similarly poor skills, whose work otherwise matched the criteria for Level 4 should be adjusted downwards within the level.

Criteria for deciding marks within a level:

- Depth and precision in the use of factual information
- Depth and originality in the development of an argument
- The extent of the synoptic links
- The quality of written communication (grammar, spelling, punctuation and legibility; an appropriate form and style of writing; clear and coherent organisation of ideas, including the use of specialist vocabulary)
- The way the answer is brought together in the conclusion

(45 marks)

## Indicative content

**Note: This content is not prescriptive and students are not obliged to refer to the material contained in this mark scheme. Any legitimate answer will be assessed on its merits according to the generic levels scheme.**

Students will need to assess/identify and evaluate/explain the condition of royal authority in England in 1154 after the disorder of King Stephen's reign and balance this against King Henry's various policies to restore his rights and authority.

Students may refer to some of the following material in support of royal success:

- Henry's attempts to restore royal authority over the English Church, his attempt to restore the ancient laws and customs, the Constitutions of Clarendon
- the reconstruction of royal government
- reforms and innovations in law and administration.

Nevertheless, there are a number of other factors to consider:

- Henry's attempts to curb baronial independence
- the restoration of royal finance
- Henry's attempt to limit the power of sheriffs.

Furthermore, students may:

- analyse the growing authority of offices of state
- analyse baronial independence and rebellion
- evaluate the restoration of royal demesne and feudal rights in the Cartae Baronum.

In conclusion, students may:

- evaluate short-term actions in the 1150s such as expelling mercenaries and demolishing adulterine castles
- evaluate the impact on royal authority of the Angevin Empire and Henry's absence from England.

**Question 2**

- 02** 'The Angevin Empire was lost because of family divisions.'  
Assess the validity of this view with reference to the years 1173 to 1216. (45 marks)

## Indicative content

**Note: This content is not prescriptive and students are not obliged to refer to the material contained in this mark scheme. Any legitimate answer will be assessed on its merits according to the generic levels scheme.**

Students will need to assess/identify and evaluate/explain familial disunity as the key reason for the collapse of the Angevin Empire and balance this against other factors.

Students may refer to some of the following material in support of familial disunity:

- the impact of the rebellion of 1173–4
- Richard's revolt in 1189, the treaty of Azay and the loss of the Auvergne
- John's rebellion in 1193 and the loss of Gisors
- the impact of the disputed succession between Arthur and John and Arthur's murder.

Nevertheless, there are a number of other factors to consider:

- the ability and feudal authority of King Philip II
- the financial impact of Richard's reign
- John's lack of military ability
- the attitude of the Norman barons.

Furthermore, students may:

- evaluate the impact of the treaty of Le Goulet 1200
- analyse the consequences of the Angouleme marriage
- focus on the loss of Normandy and the military campaign of 1203–4.

In conclusion, students may:

- range across the full period to the military defeat of John's allies at Bouvines in 1214
- stress John's resources as an issue
- highlight the long-term structural weakness of the Empire, or the importance of personal kingship.

## Indicative content

**Note: This content is not prescriptive and students are not obliged to refer to the material contained in this mark scheme. Any legitimate answer will be assessed on its merits according to the generic levels scheme.**

Students will need to assess/identify and evaluate/explain the successes in King John's relations with the English Church and the Papacy and balance this against his losses.

Students may refer to some of the following material in support of King John's success:

- the imposition and questionable impact of the interdict
- after 1209 John enjoyed huge revenues from confiscated ecclesiastical property
- the eventual compromise in 1213, England as a papal fief-humiliation or astute political move?
- King John's continued control over elections
- the role of the Papacy as a support to John during the baronial revolt, Magna Carta.

Nevertheless, there are a number of other factors to consider:

- John's failure over the Canterbury election
- papal intervention and the election of Stephen Langton
- England under the interdict and John's excommunication
- papal suzerainty over England
- the role of Stephen Langton as either co-ordinator of baronial demands or moderator and mediator after 1213.

Furthermore, students may:

- stress the wider context of increasing papal influence over the English Church
- show the links between John's dispute with the papacy and wider political conflicts with the barons and King Philip II.

In conclusion, students may:

- analyse the long-term position, John's legacy as a papal vassal, Papal power and influence in England under King Henry III
- show conceptual awareness on the nature of the relationship and the limits on Papal influence in England.
