Answer all questions.

1 A consumer research company carries out an investigation into the prices of a random sample of 11 'own brand' food items in standard sized packages from two large supermarkets, X and Y. The price, in pence, of each food item in each supermarket is given in the following table.

| Price in supermarket X | 46 | 242 | 198 | 63 | 51 | 22 | 198 | 35 | 80 | 59 | 121 |
| Price in supermarket Y | 45 | 226 | 218 | 63 | 44 | 20 | 219 | 40 | 76 | 55 | 113 |

- (a) Carry out a sign test, at the 10% significance level, to investigate whether or not the median price difference between 'own brand' food items in the two supermarkets differs from zero.

 (5 marks)
- (b) Given that the median price difference for 'own brand' food items is zero, state the probability of making a Type II error in the test that you carried out in part (a).

(1 mark)

2 In a target golf contest, Anne, Brian and Gurwyn each hit a ball towards a ring. The probability that a ball finishes inside the ring is $\frac{3}{4}$ for Anne, $\frac{2}{3}$ for Brian and $\frac{4}{5}$ for Gurwyn.

These probabilities may be considered to be independent.

Find the probability that:

(a) none of the three balls finishes inside the ring;

(2 marks)

(b) at least one of the three balls finishes inside the ring;

(1 mark)

(c) exactly two of the three balls finish inside the ring;

(3 marks)

(d) the ball hit by Gurwyn does not finish inside the ring, given that exactly two of the three balls finish inside the ring.

(2 marks)

3 A new long-life battery is being launched. It is claimed that this new battery has a median lifetime of more than 250 hours.

A trial is carried out on 15 of the new batteries, and the measured lifetimes, in hours, of 9 of these batteries are given below.

222 228 235 242 248 251 259 260 275

The remaining 6 batteries had lifetimes in excess of 280 hours.

- (a) (i) A Wilcoxon signed-rank test is to be carried out using the given data to investigate the claim. Explain why it is **not** necessary to know the exact lifetimes of the 6 batteries that had lifetimes in excess of 280 hours in order to carry out this test.

 (2 marks)
 - (ii) Carry out a Wilcoxon signed-rank test, at the 5% level of significance, to investigate the claim.

Interpret your conclusion in the context of the question. (8 marks)

(b) State **two** assumptions that are necessary in order for the test in part (a)(ii) to be valid. (2 marks)

4 [Figure 1, printed on the insert, is provided for use in this question.]

The data in the table below (repeated as **Figure 1** on the insert) were compiled for 17 randomly selected states in the USA.

It shows:

- the crime rate, x, measured as the number of offences reported per million population;
- the number, y, of males aged 16-24 years per thousand population;
- the unemployment rate, z, of males aged 16-24 years per thousand population.

Some of the rank values for x, y and z are also given in the table.

- (b) Hence, or otherwise, calculate:
 - (i) the value of Spearman's rank correlation coefficient between x and y; (3 marks)
 - (ii) the value of Spearman's rank correlation coefficient between x and z. (3 marks)
- (c) (i) Comment, in context, on your calculated value from part (b)(i). (1 mark)
 - (ii) Carry out a hypothesis test, at the 5% level of significance, to determine whether the value that you calculated in part (b)(ii) indicates an association between x and z.

 (4 marks)
- (d) Interpret your conclusion from part (c)(ii) and your comment from part (c)(i) in the context of the question. (2 marks)
- 5 A random sample of twenty school leavers, all of whom went to university and subsequently obtained jobs, is contacted and asked to state their starting salaries.

Eight of the students went to 'Top League' universities and the remaining students went to other universities.

Their starting salaries are given in the following table.

- (a) Carry out a Mann-Whitney *U* test, at the 5% level of significance, to investigate whether or not the starting salaries of those students who went to 'Top League' universities are higher than those of students who went to other universities. (12 marks)
- (b) For a test such as the one required in part (a), with two samples, one of size 8 and one of size 12, find the maximum value possible for the test statistic U.

Assume that no two observations are equal.

(2 marks)

- (c) (i) Explain how a matched pairs design could be used to investigate whether or not the starting salaries of those students who went to 'Top League' universities are higher than those of students who went to other universities. (3 marks)
 - (ii) Give the name of a suitable distribution-free test that could be used to analyse the data from the matched pairs design that you suggested in part (c)(i). (1 mark)
