Most of the ideas about the development came from the student.	Some data and facts about a material are included. Needed substantial guidance at every stage. Few of the ideas included came from the student.
		Slightly restricted range of sources. Some of the sources are identified in the bibliography. There is some indication of where the sources are used in the presentation.	At least one source of information is used directly and can be identified. There is little linkage between the sources used and the presentation.
		Some care has been taken to order the information presented. Where data is presented its inclusion is justified. Illustrations / images are usually clear.
