- 2 (a) Compare Jeremiah's new covenant with the covenant G-d made with Moses on Sinai. [25]
(b) 'Jeremiah intended to replace the Mosaic covenant.' Discuss. [10]
- 3 (a) Explain David's covenant with G-d. [25]
(b) 'Form Criticism is an essential tool for understanding the Jewish Scriptures.' Discuss. [10]
- 4 (a) Explain why and when the book of Job might have been written. [25]
(b) Assess the view that the book of Job is less important today than when it was written. [10]
