1 Read **Source** A and answer parts (a) to (c) which follow.

Source A

Prejudice and Discrimination

Prejudice is a set of learned beliefs and values that lead a person or a group of people to be biased against members of certain other groups. Our prejudices may be convenient to us but they are also inaccurate. Rather than seeing people as individuals with good and bad sides, we often stereotype them according to the group we place them in. The mass media often play a role as well by labelling particular groups.

Prejudice leads to discrimination which in turn produces disadvantage.

Discrimination can be made on the basis of a wide range of social characteristics including sexuality, disability, social class, gender and age. Discrimination can also take many different forms, ranging from verbal abuse right up to extermination.

There are various levels of discrimination:

- anti-locution (the verbal abuse of group members, e.g. name-calling);
- discrimination in jobs, housing, etc.;
- attacks on property;
- physical attacks on group members;
- genocide (the mass murder of all, or nearly all, group members).
