## **SOURCE MATERIAL**

### **SOCIAL CLASS AND CULTURAL DIFFERENCES IN THE UK**

**A recent report examines the links between social class and participation in music, reading, television and film, visual arts, sport, leisure and eating out. The aim of the research was to test the idea that social class is a *‘powerful force affecting cultural taste and practice’*.**

**The researchers used a large scale social survey conducted in 2003 and 2004. A stratified random sample from 111 postcode sectors achieved a response rate of 52% with a final sample of 1564 of the UK population aged 18+. The questionnaires collected data on:**

- **how often people took part in different cultural activities;**
- **their personal ‘likes and dislikes’, for example in books, films and sport;**
- **their occupation and income, education, gender, and parental background.**

**This quantitative data was analysed using statistical methods to explore the relationship between different variables. The study was based on the view that sociological research should be scientific and objective.**

**In this study, social class was seen as the combination of economic, cultural and social capital. Social class was not seen simply as occupation or the division of labour. Table 1 below shows some examples of cultural differences between the classes as defined and measured in this study.**

**TABLE 1 Cultural Activities By Class**

<b>Activity</b>	<b>Professional Class</b>	<b>Intermediate Class</b>	<b>Working Class</b>
<b>Watch more than 5 hours television per weekday</b>	<b>8%</b>	<b>22%</b>	<b>33%</b>
<b>Read no books last year</b>	<b>8%</b>	<b>14%</b>	<b>27%</b>
<b>Never goes to art galleries</b>	<b>30%</b>	<b>52%</b>	<b>69%</b>
<b>Soap operas favourite television programme</b>	<b>10%</b>	<b>16%</b>	<b>22%</b>
<b>News favourite television programme</b>	<b>24%</b>	<b>19%</b>	<b>14%</b>
<b>Sometimes goes to orchestral concerts</b>	<b>22%</b>	<b>12%</b>	<b>7%</b>

**The research concluded that for some cultural activities class differences are very clear. For example, the professional class, on average, attends orchestral concerts or the opera over three times more than the working classes. On the whole, professionals participate more in all practices than the working class, with the main exception being watching television.**
