Read Item A below and answer all the questions that follow.

#### Item A

In February 2008, the Australian Prime Minister, Kevin Rudd, gave a speech apologising to the indigenous peoples of Australia, in which he admitted that the past mistreatment of the Aboriginal Australians had been wrong. He stated that past policies, such as the removal of Aboriginal children from their families to raise them with white foster parents, had inflicted "profound grief, suffering and loss". The children taken from their parents were a "stolen generation" and the injustice done to them and their descendants was a wrong that had to be acknowledged for the whole country to move forward with confidence to the future.

In effect, admitted the Prime Minister, the Aboriginal Australians were treated as an internally colonised people who had been marginalised and discriminated against by past governments.

Mr Rudd said that the future of Australia, by contrast with its past, had to be based "on mutual respect, mutual resolve and mutual responsibility."
