This mark scheme includes any amendments made at the standardisation meeting attended by all examiners and is the scheme which was used by them in this examination. The standardisation meeting ensures that the mark scheme covers the candidates' responses to questions and that every examiner understands and applies it in the same correct way. As preparation for the standardisation meeting each examiner analyses a number of candidates' scripts: alternative answers not already covered by the mark scheme are discussed at the meeting and legislated for. If, after this meeting, examiners encounter unusual answers which have not been discussed at the meeting they are required to refer these to the Principal Examiner.

It must be stressed that a mark scheme is a working document, in many cases further developed and expanded on the basis of candidates' reactions to a particular paper. Assumptions about future mark schemes on the basis of one year's document should be avoided; whilst the guiding principles of assessment remain constant, details will change, depending on the content of a particular examination paper.

Question 1

Study the Introduction together with Figure 1.

What use can an archaeologist make of the map in Figure 1? (5 marks)

- L1: One or two generic points about uses of maps or lists information from source. 1-2 3-5
- L2: Attempts to link both parts of L1.

Place in L2 determined by level of detail.

Question 2

Figure 2 shows a plan of some of the features found in and around the Privy Garden area at Kirby Hall.

What survey techniques could have been used to guide the archaeologists in their choice of excavation strategy? (8 marks)

L1:	Lists a number of survey techniques or one or two points poorly developed.	1-2
L2:	More accurate explanation of how one or tow techniques work without explicit	
	link to this site or expanded list elements of all three.	3-4
L3:	Three or more techniques soundly explained with references to the site.	5-6
L4:	L3 plus clearly linked to excavation strategy.	7-8

Levels 3 and 4 expect some use of orientation/scale etc.

Question 3

Study Figures 3 and 4.

Identity the context numbers on Figure 3 that represent A, B, C and D as marked on Figure 4. (4 marks)

A = context 33B = context 4C = context 111D = context 55

Question 5

Study Figures 5(a) and 5(b) and use your own knowledge.

Discuss the uses and limitations of the excavation technique illustrated.	(7 marks)

L2:	Three or more generic points discussed or one or two with reference to a source.	3-4
L3:	Four or more points discussed with reference a source.	5-6
L4:	L3 with both sources employed.	7

Expect balance with relation to pros and cons for 6+. Allow quadrant: quartering and transects.

Question 6

Figure 6 is a photograph of a collection of human bones found in the tunnel beneath The Mount (contexts 37 and 1004 on **Figure 5(b)**).

What particular problems would an archaeologist encounter when excavating an assemblage of bones such as this? (12 marks)

- L1:Simplistic points on excavation or recording of bones or poorly explained.1-4L2:More developed points specific to excavation/recording of bones with implicit1-4
- references to source. **5-8** L3: L2 with explicit references to source. **9-12**

Use level of detail of explanation together with skill in use of source to determine place in the level.

Question 7

Figure 7 shows the upstanding remains of the bridge at Kirby Hall.

Outline the techniques that an archaeologist could have employed to record this structure. (10 marks)

- L1: Generic points (photographs, drawings, etc, higher up level the longer the list). 1-2
- L2: Knowledge of need to draw plans/elevations/record fabric etc (expect references to source for top end) or reference to use of specific equipment. 3-5 6-8
- L3: Both L2 elements.
- L4: L3 with sound use of source throughout or explanation of specialist equipment. 9-10
