Why do archaeologists produce both drawings and photographs of artefacts such as these? (6 marks)

0 5 Study Figure 3 and Figure 4 and use your own knowledge.

Outline the techniques that archaeologists can use to understand how these artefacts were made and used. (10 marks)

0 6 Study **Figure 5** and use your own knowledge.

Explain what archaeologists mean by Layer, NISP and MNI.

0 7 Look again at the Introduction, Figures 1 to 5 and use your own knowledge.

Given that the evidence at Boxgrove is 500 000 years old, describe the methods that are applicable for dating the site and the associated finds. (6 marks)

0 8 Only one hominid tooth and one hominid shin bone were recovered from Boxgrove.

What might archaeologists learn from studying these remains?
