1. Fitzroy Engineering Ltd manufactures parts for use in electrical appliances. The company was founded in 2008. At that time all of its machinery was new but today some of it is in need of replacement. One machine in particular, which was bought for £52000, is about to be sold after five years for £17000.

Show the calculations of the figures for depreciation for each of the five years using the straight-line method. [4]

2. Bubbletone plc is a manufacturer of toiletries such as shampoo and shower gel. Every year it sets a marketing budget.

Explain the benefits to Bubbletone plc of having a marketing budget and any possible problems that it might cause the company. [7]

3. SA Rogers Ltd is a manufacturer of confectionery. Its products include boiled sweets and toffees. Sam Rogers, the managing director, is worried that these products are old-fashioned and wants to make sweets that will appeal to a younger generation. At present he is considering three alternatives: buy a rival confectionery manufacturer, Zingy Sweets Ltd; refurbish his existing factory with new machinery in order to make new products; or do nothing.

Sam Rogers asked a management consultant friend to estimate the probablity of success of each of these alternatives and their estimated revenue. The results are given in the table opposite.

- (a) Use the information in the table opposite to draw a decision-tree diagram and identify the option which gives him the best return. [4]
- (b) Briefly explain TWO other factors Sam Rogers might need to consider before making his final decision as to the best course of action to take.
