## General Marking Guidance

- All candidates must receive the same treatment. Examiners must mark the first candidate in exactly the same way as they mark the last.
- Mark schemes should be applied positively. Candidates must be rewarded for what they have shown they can do rather than penalised for omissions.
- Examiners should mark according to the mark scheme not according to their perception of where the grade boundaries may lie.
- There is no ceiling on achievement. All marks on the mark scheme should be used appropriately.
- All the marks on the mark scheme are designed to be awarded. Examiners should always award full marks if deserved, i.e. if the answer matches the mark scheme. Examiners should also be prepared to award zero marks if the candidate's response is not worthy of credit according to the mark scheme.
- Where some judgement is required, mark schemes will provide the principles by which marks will be awarded and exemplification may be limited.
- When examiners are in doubt regarding the application of the mark scheme to a candidate's response, the team leader must be consulted.
- Crossed out work should be marked UNLESS the candidate has replaced it with an alternative response.

The indicative content below exemplifies some of the points that candidates may make but this does not imply that any of these must be included. Other relevant points must also be credited.</p> <p><b>Knowledge, Application, Analysis, Evaluation – indicative content</b></p> <ul style="list-style-type: none"> <li>• Cost plus pricing is a cost-based method for setting the prices of goods and services and is calculated by adding a mark-up percentage to the cost of the product.</li> <li>• It is a simple and quick way of pricing especially when <i>Primark</i> sells a large portfolio of goods.</li> <li>• The cost plus method offers a guarantee of a profit if the clothes sell. If <i>Primark</i> finds that costs are rising, it can take appropriate steps by varying the price.</li> <li>• However, this method of pricing does not take into account the actions of competitors. It may be that <i>Primark</i> could price its goods higher in line with the prices of its competitors.</li> <li>• It is often difficult to accurately calculate total costs of producing a product. <i>Primark</i> source goods from around the world. Labour costs, material costs, delivery costs, exchange changes will change regularly.</li> </ul>

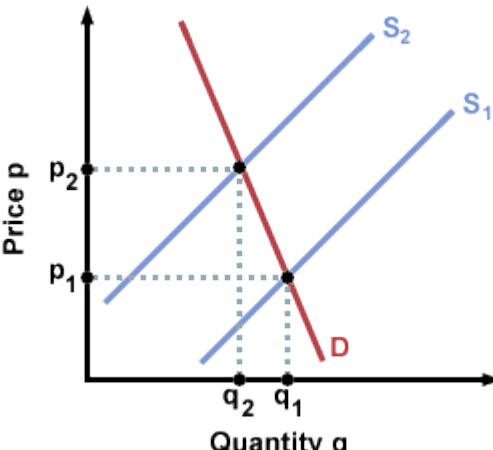

1(e)	<p><b>Indicative content guidance</b></p> <p>Answers must be credited by using the level descriptors (below) in line with the general marking guidance. The indicative content below exemplifies some of the points that candidates may make but this does not imply that any of these must be included. Other relevant points must also be credited.</p> <p><b>Knowledge, Application, Analysis, Evaluation – indicative content</b></p> <ul style="list-style-type: none"> <li>• Ethical sourcing is where a business buys materials and products that are produced using fair working conditions and/or with no negative impact on the environment.</li> <li>• The <i>Primark</i> Code of Conduct is a set of ethical principles that suppliers must commit to. The code states, amongst other things, that child labour shall not be used.</li> <li>• It is important to <i>Primark</i> as ‘there is increasing awareness about the ethics of clothes manufacturing’ and bad publicity could damage the reputation of <i>Primark</i> and impact its sales.</li> <li>• Having a reputation for poor ethics could lead to poor sales if consumers are aware/concerned about the problems.</li> <li>• Ethical sourcing may lead to improved employee motivation which may result in improved customer service for <i>Primark’s</i> customers and increased revenues for the company</li> <li>• However, sourcing ethically is costly. Paying fair wages for example will push up the cost of the clothes which may affect <i>Primark’s</i> USP of offering low prices.</li> <li>• Ethical sourcing may not be a primary objective or concern of <i>Primark</i> as they may be more concerned with keeping prices low /achieving higher market share.</li> <li>• It is debateable whether consumers are actually concerned with ethical sourcing or whether they are more concerned with low priced fashion. It may be, therefore, more important to <i>Primark</i> to keep prices low to maintain customer loyalty.</li> </ul>

Other relevant points must also be credited.</p> <p><b>Knowledge, Application, Analysis, Evaluation – indicative content</b></p> <ul style="list-style-type: none"> <li>• Segmentation is dividing the market into groups of people with similar attributes or common characteristics.</li> <li>• <i>Innocent</i> segment the market by demographics and lifestyle-products are available for younger people as well as those seeking a healthier lifestyle.</li> <li>• Focusing on specific market segments allows <i>Innocent</i> to tailor products to meet the particular needs of those customers to increase brand loyalty.</li> <li>• Market segmentation, helps <i>Innocent</i> to direct advertising and promotion to specific groups of customers to increase sales.</li> <li>• However, segmentation increases costs. When a firm attempts to serve different groups of customers the cost of production rises as well as research, promotional and distribution costs.</li> <li>• By focusing on providing healthier food and drinks there is a danger that this specialisation could lead to problems if consumers change their purchasing habits significantly.</li> <li>• The market segments identified may be too small, e.g. Coconut water, and may not generate sufficient sales to be viable / profitable for the business</li> </ul>

Other relevant points must also be credited.</p> <p data-bbox="371 577 1329 611"><b>Knowledge, Application, Analysis, Evaluation – indicative content</b></p> <ul data-bbox="371 645 1422 1429" style="list-style-type: none"> <li data-bbox="371 645 1347 712">• Test marketing involves trialling the product in a small area or to a limited number of users to assess the suitability of a product.</li> <li data-bbox="371 723 1382 835">• The smoothies were sold in 10 UK shops to test whether the product would sell. This allows <i>Innocent</i> to determine the potential success of their products.</li> <li data-bbox="371 846 1422 913">• <i>Innocent</i> are able to gather feedback and make changes to the products before launching on a larger scale and so preventing costly mistakes.</li> <li data-bbox="371 925 1353 992">• Selling in 10 shops enables them to gather sales data to assist with production planning for potential future demand.</li> <li data-bbox="371 1003 1358 1070">• However, a disadvantage of test marketing is the cost which can be expensive and time consuming.</li> <li data-bbox="371 1081 1394 1149">• Testing the new products in a limited number of shops may delay the launch of the product which may mean losing first-mover advantages.</li> <li data-bbox="371 1160 1422 1272">• During test marketing <i>Innocent</i> may run the risk of competitors learning about their products which may be copied and brought to the market earlier.</li> <li data-bbox="371 1283 1417 1429">• Results from test marketing may not be conclusive and do not always predict success. Products that sell locally might not sell well in other geographical areas. <i>Innocent</i> run the risk that the findings from the test marketing is not representative of other groups of customers.</li> </ul>

Other relevant points must also be credited.</p> <p data-bbox="371 501 1329 533"><b>Knowledge, Application, Analysis, Evaluation – indicative content</b></p> <p data-bbox="371 577 679 609"><b>Internal recruitment</b></p> <ul data-bbox="371 654 1458 1451" style="list-style-type: none"> <li data-bbox="371 654 1414 725">• Internal recruitment is when the business looks to fill a job vacancy from within the company.</li> <li data-bbox="371 734 1426 806">• <i>IKEA</i> are expanding rapidly and is looking for creative, enthusiastic people who can contribute towards their sales growth.</li> <li data-bbox="371 815 1426 931">• It is more cost efficient as the business does not have to advertise the job externally. This will help <i>IKEA</i> keep costs and prices low to enable them to remain competitive in the market.</li> <li data-bbox="371 940 1426 1093">• By recruiting internally, <i>IKEA</i> know the capabilities of the candidate, ie whether they are creative and enthusiastic and have a better idea of how they will perform in this new role. Enthusiastic staff may provide better customer service and boost sales.</li> <li data-bbox="371 1102 1382 1218">• Promoting staff from within the company can be motivating for all employees who will recognise that their hard work is rewarded and so increase productivity of the business.</li> <li data-bbox="371 1227 1458 1335">• <i>IKEA</i> will know if the internal candidate is likely to fit the <i>IKEA</i> culture and get on well with the rest of the team. Good teamwork is required to improve productivity and customer service.</li> <li data-bbox="371 1344 1458 1451">• However, internal recruitment will not bring fresh ideas or new thinking into the business. Recruiting internally will create further vacancies which will eventually need to be filled externally.</li> </ul> <p data-bbox="371 1496 684 1527"><b>External recruitment</b></p> <ul data-bbox="371 1572 1458 1962" style="list-style-type: none"> <li data-bbox="371 1572 1398 1644">• External recruitment is when the business looks to fill the vacancy from outside of the business.</li> <li data-bbox="371 1653 1458 1760">• May be preferable because <i>IKEA</i> prides itself on creative and innovative products and recruiting externally may mean there are new ideas or energy coming into the business.</li> <li data-bbox="371 1769 1458 1877">• Whilst <i>IKEA</i> has 190,000 workers internal recruitment still limits the potential number of candidates that they can choose from. External recruitment offers a wider pool of potential talent to choose from.</li> <li data-bbox="371 1886 1458 1962">• However, external recruitment is expensive and a long process and there is no guarantee you will find the right person to fit in with <i>IKEA</i>'s values.</li> </ul>



		<ul style="list-style-type: none"> <li>• Different job roles will require different skills and <i>IKEA</i> must assess if these skills can be found internally or whether external recruitment is required.</li> <li>• <i>IKEA</i> would have to look at the effectiveness of internal and external recruitment to see historically which candidates have performed the best and contributed the most to growth.</li> <li>• <i>IKEA</i> is likely to use a combination of both when recruiting staff depending on the job requirements. Also when opening a new store they may have no option but to recruit externally to fill all of the job roles required.</li> </ul>
