

# Extract A – Cottingham Parks golf and leisure club

Cottingham Parks is a family-owned and run golf and leisure club. It was opened in August 1994.

Starting with just a shipping container which was used as the clubhouse and shop, Cottingham Parks now has all the facilities you would expect at similar clubs, plus so much more. In addition to the two 18-hole golf courses, there is a health club with gym, swimming pool, jacuzzi and sauna room, plus a restaurant and bar.

In recent years, Cottingham Parks' market share has increased.

# Extract B – Cottingham Parks' membership prices

Golf membership at Cottingham Parks starts at  $\pounds 66.50$  per month which allows members to play both golf courses as many times as they want, with no additional charge. For an extra  $\pounds 25$  per month, health club membership can be added.

For people who want membership of the health club only, prices start from £37 per month. Health club members have the price of their membership fixed when they join; this means that as long as they remain members their membership price will never be increased.

The health club is open from 6.30 a.m. to 9.30 p.m. Monday to Friday, and from 7.30 a.m. to 7.30 p.m. on Bank Holidays and weekends.

# Extract E – PureGym

PureGym is one of Cottingham Parks' competitors. PureGym is the UK's largest private gym operator. At the end of 2019 it had 263 gyms and over 1.1 million members. Membership of PureGym starts at £17.99 per month.

Most PureGyms are open 24 hours a day. Members can use the gym equipment and take part in exercise classes. However, there are no swimming pools, sauna rooms or other facilities, such as a golf course.
