| 1 (b) | MMO decision | Candidate calculates the mean correctly. <br> Candidate must take the average two (or more) titres where the total spread is $\leq 0.2 \mathrm{~cm}^{3}$. <br> Working must be shown or ticks must be put next to the accurate titres selected. <br> The mean should normally be quoted to 2 dp , rounded to nearest $0.01 \mathrm{~cm}^{3}$. Example $26.667 \mathrm{~cm}^{3}$ must be rounded to 26.67 not $26.65 \mathrm{~cm}^{3}, 26.675 \mathrm{~cm}^{3}$ must be rounded to 26.68 not $26.70 \mathrm{~cm}^{3}$. <br> Two special cases, where the mean may not be to 2 dp : Allow mean expressed to 3 dp , only for 0.025 or 0.075 .
