SECTION A - MAKING A DIFFERENCE

Answer Question 1 and **either** Question 2 **or** Question 3. This section carries 30 marks.

1 Read the passage below and answer parts (a) and (b) which follow.

A Local Council Citizens' Panel

A local council set up a Citizens' Panel in 1999 in partnership with the Police and the Health Authority. The Panel has 2400 members from every walk of life and from all parts of the area.

Each member receives a questionnaire every three months, plus a newsletter telling them the results of the previous surveys and how these have been acted on.

Survey questions cover issues such as satisfaction with council services, general quality of life, community safety, transport, health and contacting the council. The answers are used to measure how well services are being delivered and to show where improvements could be made.

Your answers should refer to the passage as appropriate, but you should also include other relevant information.

- (a) Identify **two** sections of the community that you believe should be represented on a Citizens' Panel and briefly explain why. (5 marks)
- (b) Briefly examine other ways in which citizens can be involved in local decision making. (10 marks)

2 'The economy is so important to us all that the government must intervene in its running.'
Assess this statement. (15 marks)

OR

3 Assess the claim that all political power in the UK is held by central government. (15 marks)

- (c) What would be the impact on your local community if more citizens became involved in voluntary work? (15 marks)
- (d) Critically assess the claim that young people are not interested or involved in the political process. (25 marks)
