Read the passage below and answer Questions **0 1** and **0 2** which follow.

**British households pay £440 a year to be an EU member ...
but don't get it back**

The average British household paid £440 to be a member of the European Union (EU) in 2009, but received only £312 back in direct benefits, according to newly-published accounts. The £128 loss for every household is because Britain's share of the costs for running the EU is not matched by returned cash, which comes in the form of farm subsidies and social funds. The largest share of spending goes to continental farmers and poorer countries such as Poland. Britain is the fifth highest contributor to the EU budget, with £6.7 billion, after France, Germany, Italy and Spain. In Poland, every person contributes £63 and gains £166 in return subsidies. Spain is the only one of the top five contributors where the return is greater than the contribution.

Somehow I knew when I'd finished that there was enormous support for my views. The chairman of the council immediately accepted the voice of the attending public. For now, we've stopped the supermarket.
