New plans for parental leave			
There are plans to allow mothers and fathers to share parental leave on the birth of a child. The goal is to allow mothers who are the major wage earner in a household to go back to work two weeks after the birth and allow the father to take the burden of childcare. The current situation gives mothers longer maternity leave, with men getting a much shorter period of paternity leave.			
The aim of the plan is to improve equality and reduce gender discrimination. Taking time off work for childcare is considered to be one of the main reasons why women earn less and are not promoted to the highest positions in employment.

Proposed changes to workers' rights			
The Chancellor of the Exchequer has outlined plans to limit the rights of workers in exchange for their having some ownership in the company in which they work. This proposal to limit rights has been criticised by some as an attack on basic employment rights, and as an attempt to limit the responsibilities of the employer.			
Workers' rights have developed over many years and some people would be very unhappy at the idea of employees being able to give rights away. Current employment rights for UK workers include a minimum wage, minimum holiday entitlements, the right to lunch and other breaks, the right to a safe working environment, etc.
