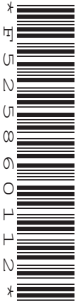

- 2 Is Document 2 an argument? Justify your answer with reference to the kinds of reasoning – such as report, anecdote (a short story about a real incident or person), argument, explanation, emotive persuasion – used in Document 2. [10]

Evaluate

- 3 Does Document 1 or Document 2 reason more effectively in support of the idea that we should be more responsible for our families?

Justify your answer by: evaluating some key strengths and weaknesses from the reasoning in both documents; considering the impact of these strengths and weaknesses on the reasoning in each document; and weighing up which document reasons more effectively. [20]

Develop your own reasoning

- 4 Responsibility should be taken more seriously in the modern western world.

To what extent do you agree with this claim? Write your own argument to support your view.

You should use your own ideas and you may use ideas/evidence from the Resource Booklet to help you. [20]
