In this examination, you will be marked on your ability to

- Student Bounty Com • respond with knowledge and understanding to literary texts of different types and periods, exploring and commenting on relationships and comparisons between literary texts (AO2ii)
- show detailed understanding of the ways in which writers' choices of form, structure and language shape meanings (AO3)
- articulate independent opinions and judgements, informed by different interpretations of literary texts by different readers (AO4)
- evaluate the significance of cultural, historical and other contextual influences on literary texts and study (AO5ii).

This means that

in your answer, you must

- (i) show an awareness of the **period** in which each play was written and of the **type** of each play – e.g. Classical Tragedy, late nineteenth-century Comedy of Manners – where relevant to the question
 - (ii) draw appropriate comparisons and contrasts between the plays
- show an understanding of the **methods** which the dramatists use e.g. character interactions, language (including imagery), structure and staging – in relation to the main issues of the question
- develop an argument in response to the statement about the text given at the beginning of the question
- provide information from outside the text, **relevant to the question**, about the context; this could be
 - historical, social, cultural circumstances in which the text was written and/or which are reflected in the text
 - literary context concerned with the type of text e.g. Tragedy, Comedy of Manners or with a particular literary notion such as the hero.

You must answer on **one** of the three synoptic options in this unn

Option A

Sophocles: *Oedipus Tyrannus* Miller: Death of a Salesman

Student Bounty.com The tragic hero is a courageous individual who confronts powerful forces within or outside himself with a dignity that reveals the breadth and depth of the human spirit in the face of failure, defeat, and even death. Oedipus and Willy may be equally described as two such individuals.

By comparing and contrasting appropriately selected parts of the two plays, show how far you would agree with the view expressed above. Your argument should include relevant comments on each writer's dramatic methods and contextual material on the nature of the tragic hero.

Option B

Farquhar: The Beaux' Stratagem

Wilde: An Ideal Husband

COM Even though Farquhar was writing almost two centuries before Wilde, a modern audience can relate much more easily to Aimwell and Archer, the central characters in The Beaux' Stratagem, than they can to the central characters in An Ideal Husband, Lord Goring and Sir Robert Chiltern, who seem too remote from modern life.

By comparing and contrasting appropriately selected parts of the two plays, show how far you would agree with the view expressed above. Your argument should include relevant comments on dramatic methods and contextual material on the Comedy of Manners.

Option C

Webster: The Duchess of Malfi

Albee: Who's Afraid of Virginia Woolf?

Student Bounty Com Martha may be foul-mouthed, vulgar and cruel, and therefore completely unlike the noble and dignified Duchess, yet she succeeds in arousing in the audience the tragic feelings of pity and fear, and so is just as deserving of the description "tragic heroine" as the Duchess.
