1 Study the available information, making particular reference to the census figures for Dene Ward (Item 5).

To what extent does this support the new management's view that there is likely to be an increased local demand for sports facilities of a high standard?

2 Any development of new sports facilities and associated car parks for the club may cause changes to the flow of the Ouse Burn, which may in turn affect the physical geography of the valley. Suggest what these changes might be, and how developments could be planned so as to minimise the harmful effects.

3 The management of the club is considering the development of one of the four sites described in **Item 6** of the Information Booklet. The management wants to anticipate any objections to the development that might come from the local community.

Apart from the impact on drainage, what problems and/or benefits for the local community might result from the development at **each of the four sites**, **a–d**?

(15 marks)

4 Although they will consider the views of the local community, the club management's main objective is to increase membership and use of the club and so increase profits.

The management know that each of the sites, a–d, could be used **either**:

- to build two squash courts, with car parking for about 20 cars, or
- to develop car parking for about 80 cars.

Given the management's aim of increasing profits you must decide:

- (i) which site is most suitable:
- (ii) whether it should be developed as squash courts with some parking, or just for car parking. Justify your answer.
