Student Bounty Com The role of the state should be to regulate society by providing a framework of laws. The state should also ensure that the laws are properly enforced: those who break the law should be punished and must be seen to be punished. If a state fails in this duty then it will result in widespread disregard for the law and an epidemic of crime. The removal of the death penalty in the UK was a serious mistake, based upon a naïve view of human nature. The evidence confirms that, where capital punishment has been retained, society benefits.
