StudentBounty.com The Civil Rights Act and Voting Rights Act effectively ended segregation after a lengthy campaign. Finally, the 14th and 15th Amendments to the Constitution were being applied. Did this mean that the Constitution, belatedly, provided freedom and equality of opportunity for all? Some in the African-American community expressed the view that the new acts would be insufficient to end 200 years of segregation and discrimination. The denial of freedom and equality could not meaningfully be overcome by the passage of two pieces of legislation.

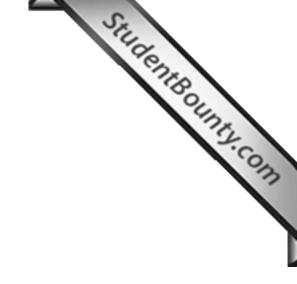

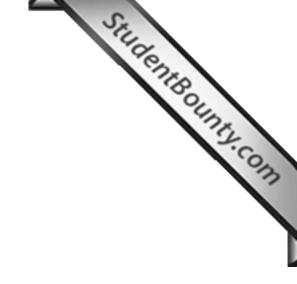


