# Study the source below and answer the question that follows.

# Source

The United States Constitution was drawn up in an age when the expectations of government were few; the United States was a new and weak state in the international system; loyalties were essentially local; there were no national parties. All this has changed.

Now that the United States is a superpower, it is essential that there should be a strong but fully accountable government. The key to this was the creation of a Separation of Powers. However, critics argue that this system of separated powers has increasingly led to gridlock in the US political system. It has produced government that is neither strong nor accountable.

# Study the source below and answer the question that follows.

# Source

The Irish constitution is now past its sell-by date. Its key weakness is that it was written for another era. The Presidency and the Oireachtas have both become irrelevant. This has happened because governments naturally seek to monopolise power but also because of an electoral system that leads to a focus on local issues rather than national ones. The powerlessness of the Seanad is just one, among many, problems. Seeking to reform these issues bit-by-bit just won't work. Instead we need to do what de Valera did in 1937: tear it up and start again.
