 - (iii) Paul had nothing to do as he sat for an hour in the waiting room. (1 mark)
 - (iv) Bernadette would have preferred to have a friend or relative with her when the social worker came to interview her, but no-one was available. (1 mark)
 - (v) Sara's parents often criticise her, but never praise her or show her much affection.

 - (b) Suggest and outline **three** benefits which elderly clients might gain from attending a day centre. (6 marks)
- **4** (a) (i) Outline the service provided by the Accident and Emergency department of an NHS Trust hospital, from the patient's arrival to his or her departure. (6 marks)
 - (ii) State **two** ways in which patients can get access to Accident and Emergency treatment. (2 marks)
 - (b) Name and outline **one** other service usually provided by NHS Trust hospitals. (3 marks)
 - (c) (i) Suggest **two** precautions hospital staff can take to reduce the risk of patients contracting MRSA. (2 marks)
 - (ii) Suggest **two** precautions hospital staff can take to reduce the risk of contracting HIV from infected patients. (2 marks)
