Carry out an investigation of service provision in relation to service users with **physical disabilities or illnesses**. Your investigation should address the following:


- The Disability Discrimination Act 1995 and Disability Discrimination (NI) Order 2006 and how it has improved the lives of people with disabilities.
- The Carers and Direct Payments Act (NI) 2002 and how it supports informal carers.
- An understanding of the content of a range of policies found in care settings.
- Reasons for the increase in the population of people with physical disabilities and long term illnesses.
- The advantages and disadvantages of different sectors of the mixed economy providing care.
- The funding of services in the mixed economy of care.
- The role of informal carers and how they support individuals with physical disabilities or long term illnesses.
- Meeting the needs of service users with physical disabilities and long term illnesses.
- Accessing services and breaking down barriers to access faced by those with physical disabilities and long term illnesses.
- The roles of a range of practitioners who provide care and support in a hospice setting.

- In a health survey conducted in Northern Ireland in 2011, 37% of respondents reported that they had a long term illness. The proportion of respondents reporting this increased with age, from 14% of 16–24 year olds to 70% of those aged 75 and over. In the same survey, 14% of respondents indicated that they cared for someone else on an informal basis with females more likely to be carers than males.






