# General Comments

There was a small entry this series but there were still some issues that caused concern. Some candidates included large amounts of information taken directly from the internet which, although referenced tended to take the place of the candidates own input and the overuse of sources is something that candidates should be discouraged from especially as it detracts from the candidates analysis and evaluations in AO3 and 4, and their focus in AO1.

## A01

The successful candidates had chosen relevant issues and linked them to the public health consequences. This was the first time that quality of written communication had been assessed in this assessment objective and the main problem this caused for candidates was their ability to produce a focussed report. Because of the tendency to include large amounts of information from the internet, candidates often lost focus and found it hard to achieve at the highest levels.

## AO2

The successful candidates had chosen relevant issues and linked them to a specified group of the population, and then identified the relevant social, environmental and lifestyle issues that were relevant to that section of the population. This section leads directly into the analysis in AO3. Some candidates are still not identifying a specified group of the UK population and are making the work harder for themselves, and losing focus thus losing marks in AO1.

## AO3

Some candidates showed good skills in obtaining information from literature searches but need to be encouraged to be more selective about the information they use in their final report and they should take care to reference all the work that they quote. It is good practice to ensure that candidates include bibliographies to reports. At mark band 2 and 3 they are required to analyse environmental and lifestyle problems in relation to the public health issue. Although the descriptions were seen in AO2 there are still few attempts at realistic analysis seen and what attempts were seen are still being overmarked.

# A04

This is an assessment objective that candidates still find difficult. Even the stronger candidates tend to submit descriptions and information from websites rather than evaluations of strategies, making it harder for them to access the higher marks in mark band 3. Evidence that the candidates had thought themselves about the issue and drawn some conclusions from the information they have considered needs to be seen. Candidates need guidance on both analysis and evaluation at this stage to ensure that they can achieve Mark Band 3. The process is new to them and should be supported by their Centres.
