3(b)	The candidates need to relate their answers to one social group. Accept a wide definition of social group. Not just gender, age, ethnicity but also include children, teenagers, students, etc
	Responses are likely to relate to:
	 Stress Anxiety Depression Poor diet Mental health problems Poor hygiene Social exclusion Marginalisation Excluded from activities Poor living conditions Respiratory problems Obesity
	Accept any justifiable effect. The candidates can be credited for developing one effect of poverty up to a maximum of 4 marks (one mark for the effect and 3 marks for its development related to one social group). Or 2 identifiable effects which are explained and related to one social group. If the candidate identifies two effects of poverty but relates them to two different social groups a maximum of 2 marks to be awarded.
