# 2 Post-Impressionism and Symbolism in Europe

Discuss the aims and work of **one** of the following: Cézanne, Munch or Rodin. (20 marks)

#### 3 19th and Early 20th Century Architecture

Outline some of the developments in architecture in Britain between c.1850 and c.1900, with reference to the work of **at least two** architects.

(20 marks)

## 4 Early 20th Century Movements in Europe

Outline the development of Cubist painting in France between c.1907 and c.1914. Answer with reference to specific examples. (20 marks)

# 5 Abstract Art in Europe (excluding Cubism)

Outline the aims and achievements of De Stijl artists **and** assess their contribution to abstract art.

(20 marks)

#### **6** Modernist Architecture

Identify ways in which the work of European architects between c.1920 and c.1940 exhibits characteristics of Modernist architecture. Refer to the work of **at least two** architects. (20 marks)

#### 7 Art Between the Wars in Europe

In what ways does the work of either Miró or Magritte show Surrealist characteristics?

(20 marks)

## 8 Painting, Sculpture and other Media in the Mid-20th Century

Examine the materials and techniques used in the work of at least two Minimalist artists.

(20 marks)

# 9 Art in the Later 20th Century

Describe and comment on **two** works of art, each by a different artist, made between c.1970 and 1990 which make reference to contemporary social issues. (20 marks)

# 10 Later 20th Century Architecture

Describe the characteristics of the architecture of **either** Philip Johnson **or** Robert Venturi.

Answer with reference to specific examples.

(20 marks)
