All questions should be answered in continuous prose. The legibility of your handwriting and the accuracy of your spelling, punctuation and grammar will also be considered.

Answer three questions, one each on painting, sculpture and architecture.

All the questions in this paper are about the photographs of works of art provided on pages 3 to 8. This unit tests visual skills. You are expected to identify the formal and stylistic elements and you should comment on the use of materials and the context in which works of art are produced and used. The photographs should be detached from the rest of the question paper.

- 2 Francis Bacon, *Study for a Portrait (Man in Blue Box)*, 1949 (oil on canvas) (149.3 cm × 130.6 cm) (Museum of Contemporary Art, Chicago).
 - (a) Comment on the artist's representation of the figure and its setting in this painting. (5 marks)
 - (b) Comment on the use of colour and brushwork in this painting. (5 marks)

Sculpture

- **3** Luca della Robbia, panel of choristers from *Singing Gallery*, 1431–1438 (marble) (100 cm × 94 cm) (Museo dell'Opera del Duomo, Florence).
 - (a) How has the sculptor represented the scene in this sculpture? (5 marks)
 - (b) Comment on the sculptor's techniques of carving in marble in this sculpture.

- 4 Jacob Epstein, *The Risen Christ*, 1917–1919 (bronze) (218.5 cm high) (Scottish National Gallery of Modern Art).
 - (a) How has the sculptor represented *The Risen Christ*? (5 marks)
 - (b) How has the sculptor exploited the material and techniques in this sculpture?
