All questions should be answered in continuous prose. The legibility of your handwriting and the accuracy of your spelling, punctuation and grammar will also be considered.
- Examples of works of art and/or architecture chosen for description in answering one question should **not** be used again in answering another question in this paper.

Answer **two** questions.

1 Realism and Impressionism in France

Discuss and comment on the representation of women in Realist **and/or** Impressionist painting. Refer to **at least two** paintings, each by a different artist. (20 marks)

2 Post-Impressionism and Symbolism in Europe

Discuss the representation of landscapes **and/or** outdoor rural scenes in the work of **two** of the following painters:

Van Gogh; Cézanne; Gauguin.

Refer to specific examples in your answer.

3 19th and Early 20th Century Architecture

Discuss the approach to domestic architecture demonstrated in **two** houses, built between c.1850 and c.1910, in Europe **and/or** the United States. (20 marks)

4 Early 20th Century Movements in Europe

Identify the principal stylistic characteristics of Fauvist paintings with reference to the work of **two** artists. (20 marks)

5 Abstract Art in Europe (excluding Cubism)

Outline the aims and achievements of De Stijl artists **and** assess their contribution to abstract art. (20 marks)

6 Modernist Architecture

Describe and comment on **two** Modernist buildings in the United States, each designed by a different architect between c.1920 and c.1960. (20 marks)

7 Art Between the Wars in Europe

In what ways does the work of either Miró or Magritte show Surrealist characteristics? (20 marks)

8 Painting, Sculpture and other Media in the Mid-20th Century

'Abstract Expressionist painting divides into two groups.' Identify the similarities and differences between each group with reference to specific examples. (20 marks)

9 Art in the Later 20th Century

Describe and discuss **two** works of art created between c.1970 and 1990 for a specific site in the landscape in which elements of the landscape form part of the work. (20 marks)

10 Later 20th Century Architecture

Outline developments in architecture in **either** Europe **or** the United States between c.1960 and 1990. Answer with reference to specific examples. (20 marks)
