Section 10 – Automotive design 1945–present

10 In relation to automotive design 1945–present, critically appraise the work of one designer or manufacturer specializing in family car design and one designer or manufacturer specializing in another form of automotive design. Establish contexts and refer to appropriate examples. [60]
