SECTION A: AFRICAN AMERICANS 1877–1980

You must answer this question.

You are advised to spend about 45 minutes on this question.

- 1 Study the following source material and then answer the questions which follow.
 - **Source A** In the decades before 1920 many white Americans did not so much discriminate against the African American population, as fail to see them, as if they were invisible. Excluded from positions of power and influence, African Americans simply did not matter. The humble peanut changed
 - 5 this attitude. In 1921, George Washington Carver, a former slave, developed a new product: peanut butter. Carver showed both white and black Americans that an African American could accomplish great things.

- **Source B** Adapted from an American History text book written in 1984 reviewing the period since 1945
 - Since World War II, there have been private efforts against discrimination. Corporations have sought qualified blacks for skilled factory, clerical and project positions. White industrial unions have extended membership to African Americans. Major League Baseball dropped its colour bar in 1947,
 - when Jackie Robinson became the first African American to play in the Major League. Since 1950, movie producers have stopped portraying African Americans as happy-go-lucky stereotypes and have started presenting them as human beings.
- **Source C** Black civil rights leaders were encouraged to get their people, the victims of decades of racist thuggery and violence, to turn out in elections. Increasingly, however, black civil rights activists and their liberal white supporters took action on their own, sending so-called 'freedom riders' into the Segregationist
 - 5 South. This reflected the pace of change initiated by President Kennedy and his brothers. Nevertheless, such groups still needed federal protection.
