- 1 Study the following source material and then answer the questions which follow.
 - Source A The clauses of the Treaty of Paris and the decree of a council held at Toulouse in November 1229 demonstrated that twenty years of crusading had not been very effective, since heresy was as much a concern as ever. The fact was that crusading, particularly when as episodic as this type was, could not eradicate deep-rooted heresy. It required the establishment of the inquisition in Toulouse in 1233 and the persistent pressure that such an instrument could bring to bear for headway to be made: from 1250 the Cathar leaders were withdrawing to Lombardy; by 1324 southern French Catharism was dead.
