1 Study the following source material and then answer the questions which follow.

Source A

A brief text extract adapted from K JARAUSCH, The Rush to German Unity, 1994, discussing the use of secret police, the Stasi, in identifying and suppressing dissent against the government in East Germany. Not reproduced here due to third-party copyright constraints.

Source B

A brief text extract adapted from a Stasi 'state of the nation' report, September 1989, acknowledging the shortcomings of socialism for the citizens of the GDR. Not reproduced here due to third-party copyright constraints.

Source C

A brief text extract adapted from M FULBROOK, Anatomy of a Dictatorship, 1995, discussing the discontent amongst the East German populace, with their economic situation. Not reproduced here due to third-party copyright constraints.

(a) Use **Source** A and your own knowledge.

Assess the validity of the view in **Source A** about why there was so little political opposition in the GDR before the summer of 1989. (10 marks)

(b) Use **Source B** and your own knowledge.

How useful is **Source B** as evidence about the reasons for the growth of opposition within the GDR by September 1989? (10 marks)

(c) Use Sources A, B and C and your own knowledge.

'It was the loss of support from its own citizens which brought about the downfall of the GDR in November 1989.'

Assess the validity of this view.
