### Answer all questions.

1 Study the following source material and then answer the questions which follow.

### Source A

A brief text extract adapted from J BRADBURY, Stephen and Matilda, 1996, discussing the extremely probable existence of an exchequer under the rule of Stephen even though there are no actual records to support this. Not reproduced here due to third-party copyright constraints.

### **Source B** From *A History of English Affairs* by William of Newburgh, c1190

At first it seemed the kingdom of England was to be cut in two, some supporting the king, others the empress; but neither king nor empress was in control of their supporters, for each depended from day to day on their people's military efforts. Neither could curb or dictate to their party, and both appeased their supporters,

- 5 denying them nothing, in case they withdrew their support.
- **Source C** It has sometimes been claimed that the revolt of Geoffrey de Mandeville was an isolated event, and that all the horrors of the so-called Anarchy should be referred to this one time and place, but the evidence to the contrary is far too strong to be ignored. The *Gesta Stephani*, for example, was primarily concerned with the
  - 5 West Country, but it is loud in its complaints at the conditions endured at all periods of the reign.

- **Source D** The Peterborough Abbey chronicler gives a generalised description of the nineteen winters when 'Christ and his saints slept' and England suffered for its sins. The barons, the Peterborough chronicler said, ruthlessly exploited Stephen's weakness to assert their independence, government ceased to function, and horrifying
  - 5 oppressions were continuously inflicted on the Church and common people. All this was Angevin propaganda: Henry II's accession was seen as a legitimist restoration, and nothing good could be said about Stephen's regime.

(a) Use **Source A** and your own knowledge.

Assess the validity of the view in **Source A** about the 'anarchy' of Stephen's reign.

(b) Use **Source B** and your own knowledge.

How useful is **Source B** as evidence about the causes of disorder? (10 marks)

(c) Use **Sources A**, **B**, **C** and **D** and your own knowledge.

'Government remained effective throughout Stephen's reign.' Assess the validity of this view. (20 marks)
