Mark Scheme

Mark schemes are prepared by the Principal Examiner and considered, together with the relevant questions, by a panel of subject teachers. This mark scheme includes any amendments made at the standardisation meeting attended by all examiners and is the scheme which was used by them in this examination. The standardisation meeting ensures that the mark scheme covers the candidates' responses to questions and that every examiner understands and applies it in the same correct way. As preparation for the standardisation meeting each examiner analyses a number of candidates' scripts: alternative answers not already covered by the mark scheme are discussed at the meeting and legislated for. If, after this meeting, examiners encounter unusual answers which have not been discussed at the meeting they are required to refer these to the Principal Examiner.

It must be stressed that a mark scheme is a working document, in many cases further developed and expanded on the basis of candidates' reactions to a particular paper. Assumptions about future mark schemes on the basis of one year's document should be avoided; whilst the guiding principles of assessment remain constant, details will change, depending on the content of a particular examination paper.

# **Generic Introduction for AS**

The AS History specification is based on the assessment objectives laid down in QCA's GCE History subject criteria and published in the AQA specification booklet. These cover the skills, knowledge and understanding which are expected of A Level candidates. Most questions address more than one objective since historical skills, which include knowledge and understanding, are usually deployed together. Consequently, the marking scheme which follows is a 'levels of response' scheme and assesses candidates' historical skills in the context of their knowledge and understanding of History.

The levels of response are a graduated recognition of how candidates have demonstrated their abilities in the Assessment Objectives. Candidates who predominantly address AO1(a) by writing narrative or description will perform at Level 1 or Level 2 depending on its relevance. Candidates who provide more explanation – (AO1(b), supported by the relevant selection of material, AO1(a)) – will perform at high Level 2 or low-mid Level 3 depending on how explicit they are in their response to the question. Candidates who provide explanation with evaluation, judgement and an awareness of historical interpretations will be addressing all 3 AOs (AO1(a); AO1(b): AO2(a) and (b) and will have access to the higher mark ranges. AO2(a) which requires the evaluation of source material is assessed in Unit 2.

Differentiation between Levels 3, 4 and 5 is judged according to the extent to which candidates meet this range of assessment objectives. At Level 3 the answers will show more characteristics of the AO1 objectives, although there should be elements of AO2. At Level 4, AO2 criteria, particularly an understanding of how the past has been interpreted, will be more in evidence and this will be even more dominant at Level 5. The demands on written communication, particularly the organisation of ideas and the use of specialist vocabulary also increase through the various levels so that a candidate performing at the highest AS level is already well prepared for the demands of A2.

# **General Guidance for Examiners (to accompany Level Descriptors)**

# Deciding on a level and the award of marks within a level

It is of vital importance that examiners familiarise themselves with the generic mark scheme and apply it consistently, as directed by the Principal Examiner, in order to facilitate comparability across options.

The indicative mark scheme for each paper is designed to illustrate some of the material that candidates might refer to (knowledge) and some of the approaches and ideas they might develop (skills). It is not, however, prescriptive and should only be used to exemplify the generic mark scheme.

When applying the generic mark scheme, examiners will constantly need to exercise judgement to decide which level fits an answer best. Few essays will display all the characteristics of a level, so deciding the most appropriate will always be the first task.

Each level has a range of marks and for an essay which has a strong correlation with the level descriptors the middle mark should be given. However, when an answer has some of the characteristics of the level above or below, or seems stronger or weaker on comparison with many other candidates' responses to the same question, the mark will need to be adjusted up or down.

When deciding on the mark within a level, the following criteria should be considered *in relation* to the level descriptors. Candidates should never be doubly penalised. If a candidate with poor communication skills has been placed in Level 2, he or she should not be moved to the bottom of the level on the basis of the poor quality of written communication. On the other hand, a candidate with similarly poor skills, whose work otherwise matched the criteria for Level 4 should be adjusted downwards within the level.

Criteria for deciding marks within a level:

- The accuracy of factual information
- The level of detail.
- The depth and precision displayed
- The quality of links and arguments
- The quality of written communication (grammar, spelling, punctuation and legibility; an appropriate form and style of writing; clear and coherent organisation of ideas, including the use of specialist vocabulary)
- Appropriate references to historical interpretation and debate
- The conclusion

#### Question 1

**01** Explain why US foreign policy, during the 1890s, moved away from isolationism.

(12 marks)

Answers should include a range of reasons as to US foreign policy, during the 1890s moved away from isolationism.

Candidates might include some of the following factors:

- the geographical location of Hawaii, Cuba and other islands in relation to the USA and its sphere of influence
- the commercial reasons sugar trade and plantations

- the expansion of the USA politically to rival other nations
- influence of the Yellow Press on President McKinley
- influence of Mahon's book on the navy
- influence of Theodore Roosevelt
- the financial reasons investment in Hawaii, Cuba etc by business
- specific incidents such as the sinking of the Maine in 1898

To reach the higher levels, candidates will need to show the inter-relationship of the reasons given, for example they might explain how trade and financial reasons compelled the President to move away from isolationism.

How important was President Theodore Roosevelt to the development of American imperialism in the years 1890 to 1914? (24 marks)

Factors suggesting importance might include:

- President Roosevelt's early career as Rough Rider
- President Roosevelt developed Imperialism through policies such as Open Door and his Corollary
- · Roosevelt and his actions in Columbia and Panama

 President Roosevelt's firm belief in Imperialism and his attempts to influence other Presidents.

Factors suggesting non importance might include:

- Theodore Roosevelt did not come to prominence until 1897 and President Grover Cleveland was responsible for some early actions connected to Hawaii
- President McKinley went to war against Spain in 1898 and took over Cuba and the Philippines and Guam
- President Taft believed in Dollar Diplomacy which was an economic form of Imperialism
- President Wilson and his interest in the affairs of Mexico/Latin America
- end of the Frontier and the search for markets.

Good answers are likely to show an awareness that President Theodore Roosevelt was very important to the development of American imperialism in the years 1890 to 1914 because of both his beliefs and actions.

**03** Explain why there was an increase in organised crime in the USA after 1919.

(12 marks)

Answers should include a range of reasons as to why organised crime increased in the USA after 1919.

Candidates might include some of the following factors:

- the introduction of prohibition in 1919
- the success of some gangsters such as Al Capone led to more people becoming gangsters
- the ability to make easy money because of the high demand for liquor
- the limited chance of being caught by the law because of endemic corruption.

To reach the higher levels, candidates will need to show the inter-relationship of the reasons given, for example they might explain that the number of gangsters rose because people wanted to drink and Al Capone and other gangsters were just supplying a need with little chance of being caught because of corrupt policemen.

How important was the impact of organised crime on American society in the years 1920 to 1929? (24 marks)

# **Indicative content**

Note: This content is not prescriptive and candidates are not obliged to refer to the material contained in this mark scheme. Any legitimate answer will be assessed on its merits according to the generic levels scheme.

Factors suggesting importance might include:

- organised crime led to an increase in violence in the cities such as Chicago because of fights such as the St Valentines Day massacre and this caused general unease and fear
- organised crime led to an increase in the amount of illicit liquor and drugs which meant social problems rose in the home

- organised crime led to an increase in racism against Italians because they were most associated with this
- organised crime led to more ordinary people breaking the law to drink and have a good time and showed the instability of society
- cynicism about law enforcement and justice grew.

# Factors suggesting non importance might include:

- sections of society were left untouched by organised crime especially amongst Baptists in the South; here society was little changed
- society was already suffering from the 'perils of prosperity', i.e. loosening of moral standards
- gangsters were limited by the actions of the FBI and hence effect on society
- organised crime had little effect on those who made their own narcotics and liquor
- immigrant culture had an effect on society leading to gangs of different nationalities
- prosperity/boom had an effect on society, e.g. on women
- KKK caused fear in society
- Entertainment industry was a greater influence with people copying their heroes.

Good answers are likely to show an awareness that not all was well in the 1920s (perils of prosperity) and that organised crime was a symptom rather than a cause of change for society.

**05** Explain why Congress passed Neutrality Acts in the years 1935 to 1937. (12 marks)

Answers should include a range of reasons as to why Congress passed the Neutrality Acts in the years 1935 to 1937.

Candidates might include some of the following factors:

- Congress did not want to engage in hostilities and be drawn into a European war on any side
- traditional foreign policy was to remain isolationist
- to stop American citizens travelling on ships of warring nations
- to stop firms supplying arms to belligerents
- to stop bankers giving loans to nations at war

To reach the higher levels, candidates will need to show the inter-relationship of the reasons given, for example they might explain that Congress wanted to keep out of another war and they felt compelled to keep the USA neutral through a series of laws based on traditional foreign policy.

O6 How important was American public opinion as a reason for the USA entering World War Two? (24 marks)

#### Indicative content

Note: This content is not prescriptive and candidates are not obliged to refer to the material contained in this mark scheme. Any legitimate answer will be assessed on its merits according to the generic levels scheme.

Factors suggesting importance of American public opinion as a reason for the USA to enter World War Two might include:

 as early as the sinking of the Panay in 1937 there were calls for war against the Japanese from some members of the public and Congress

- public opinion changed after 1939 and the war in Europe started this and put pressure on Congress
- public joined Defend America by aiding the Allies and this created a powerful lobby group
- public wrote letters to newspapers in 1940-1941 wanting USA to go to war
- outrage by the public after Peal Harbour confirmed Roosevelt's decision showing where their sympathies lay.

# Factors suggesting non importance might include:

- public opinion was divided and there were a number of isolationists such as the America First Committee
- public in 1937 only small percentage for war so easily ignored by Congress
- many members of the public remembered deaths in World War One and so did not want another war
- President Roosevelt was waiting to declare war and Pearl Harbour gave him the excuse.
- President Roosevelt had imposed sanctions against Japan which had in effect caused the Japanese to react.

Good answers are likely to show awareness that public opinion changed once Hitler got to the Channel and this changed many isolationists' views but the main event was Pearl Harbour.
