	 Evaluate the interpretations in both of the two passages and explain which you think is more convincing as an explanation of the conduct and outcome of the American Civil War. In locating the Interpretations within the wider historical debate, answer might argue that Interpretation A puts forward the view that the role of commanders was crucial in the outcome of the war despite the development of mass production. In evaluating Interpretation A, answers might argue that once the Union found good commanders, such as Grant and Sherman they made rapid progress to victory. Answers might argue that Interpretation A is invalid as Grant and Sherman won because their armies were larger. Answers might argue that Interpretation A is not valid as it ignores the importance of economic resources and manpower. Answers might argue that Interpretation A is valid and point to the role of commanders at Vicksburg in 1863 and Atlanta, as well as the march through Georgia and the Carolinas. In locating the Interpretations within the wider historical debate, answers might argue that Interpretation B puts forward the view that 	30	 No set answer is expected. At Level 5 and above answers will evaluate both interpretations, locating them within the wider historical debate about the issue and using their own knowledge, and reach a balanced judgement as to which they consider the most convincing about the issue in the question. Answers might consider that digging trenches became a major feature in the American Civil 	 No set answer is expected. At higher levels answers might establish criteria against which to judge. To be valid, judgements must be supported by relevant and accurate material. Knowledge must not be credited in isolation, it should only be credited where it is used as the basis for analysis and evaluation, in line with descriptions in the levels mark scheme.

- Answers might consider that numerical superiority was crucial.
- **Answers might consider** the role of commanders, particularly in the period to 1865, in determining the outcome of wars.
- **Answers might consider** that alliances, as in the Second World War, determined the outcome.
- **Answers might consider** that weapon advantage does not always determine the outcome as happened in World War I when the tank was not used effectively.
- **Answers might consider** that in most wars it was not one factor, but a combination of factors that determined the outcome.

How effectively did states mobilise their economies for war in the period from 1792 to 1945?

4	 In supporting the hypothesis in the question, it might be argued that the mobilisation of economies became more important as the period progressed. Answers might consider how effectively Prussia mobilised its economy during the 1860s and compare that with Austria, and may also consider that the greater mobilisation of the Union gave it an advantage in the American Civil War. Answers might consider that economies that could produce changes in weaponry and transport were successful in colonial wars. Answers might consider the increase in arms manufacture in the period after 1900. Answers might consider how countries were able to mobilise their economies for long periods of warfare in the twentieth century and may also consider the mobilisation by Napoleon of France in producing weapons and the financial mobilisation by Britain to sustain opposition. Answers might consider that attempts to destroy the great approach that attempts to 	No set answer is expected. At higher levels answers might establish criteria against which to judge. There may be some use of information from one of the two terpretations to support the evaluation of the other, but the evaluation will not rely on this. There is a limited analysis of the terpretations in relation to the question.
he answer has a limited focus on the question. Parts of the answer are just description of the interpretations, with evaluation in elation to historical context and the wider historical debate around the issue being weak, and evaluation relying heavily on formation drawn from the other interpretation. There is a very limited analysis of the interpretations in relation to the question.
he answer has some relevance to the topic, but not the specific question. The answer consists mostly of description of the terpretations with very limited evaluation based on very generalised knowledge of historical context and minimal or no reference the wider historical debate. Analysis of the interpretations in relation to the question is either in the form of assertion or lacking.

Level 6 21–25 marks	The answer has a very good focus on the question. Detailed and accurate knowledge and understanding is used to analyse and evaluate key features of the period studied in order to reach a fully developed synthesis supporting a convincing and substantiated judgement. There is a well-developed and sustained line of reasoning which is coherent and logically structured. The information presented is entirely relevant and substantiated.
Level 5 17–20 marks	The answer has a good focus on the question. Generally accurate and detailed knowledge and understanding is used to analyse and evaluate key features of the period studied in order to reach a developed synthesis supporting a substantiated judgement. There is a well-developed line of reasoning which is clear and logically structured. The information presented is relevant and in the most part substantiated.
Level 4 13–16 marks	The answer is mostly focused on the question. Relevant knowledge and understanding is used to analyse and evaluate key features of the period studied in order to reach a synthesis supporting a reasonable judgement. There is a line of reasoning presented with some structure. The information presented is in the most-part relevant and supported by some evidence.
Level 3 9–12 marks	The answer has a partial focus on the question. Some relevant knowledge and understanding is used to analyse and explain key features of the period studied in order to attempt an undeveloped synthesis, which is linked to a judgement, though the supporting explanation may lack detail and clarity. The information has some relevance and is presented with limited structure. The information is supported by limited evidence.
Level 2 5–8 marks	The answer has only a limited focus on the question. Limited relevant knowledge and understanding is used to give a limited explanation and analysis of key features of the period studied. There is a judgement but this may not be clearly linked with the supporting explanation. The information has some relevance, but is communicated in an unstructured way. The information is supported by limited evidence and the relationship to the evidence may not be clear.
Level 1 1–4 marks	The answer has a limited focus on the topic, but not the specific question. The answer is largely descriptive, with only very generalised knowledge of the period studied being used to attempt basic explanation and very limited analysis. Judgements are unsupported and are not linked to analysis. Information presented is basic and may be ambiguous or unstructured. The information is supported by limited evidence.
