#### Section A

- 1 Explain why significant changes were made to the caliphate under the Umayyad dynasty. [20]
- 2 It is often said that the 'Abbasids were more 'Islamic' than the Umayyads. Do you agree? Give reasons to support your view. [20]
- 3 (a) Outline the main achievements of any **three** of the following caliphs: 'Abd al-Malik, Harun al-Rashid, al-Ma'mun, al-Mutawakkil. [12]
  - (b) Explain the importance of the office of caliph in the Umayyad and early 'Abbasid state. [8]

#### **Section B**

- 4 'Al-Shafi'i is often seen as the most important of the founders of the four Islamic law schools.' Explain whether you agree or disagree with this opinion. [20]
- Numerous collections of the Prophet's Sunnah were made in the first three centuries of Islam. Why were the Six Canonical Collections (the Sahih Sittah) eventually judged more reliable than any others?

- 6 (a) Give an outline of the main characteristics of the Muʿtazilah school of theologians. [12]
  - **(b)** Why did the influence of the Mu'tazilah decline in the later ninth and tenth centuries? [8]

## **Section C**

- 7 (a) Give an account of the massacre of the Imam Husayn and his family at Karbala'. [12]
  - **(b)** Explain the significance of Husayn's death for Shi'i Muslims. [8]
- With reference to at least **two** Sufis, explain how Sufism differed from other forms of Islam in the early Islamic era. [20]
- **9** By referring to the concepts of reason and revelation, explain the main differences between Muslim philosophers and theologians. [20]
