#### Criminal Law

# 1 Total for this question: 25 marks

Richard was riding his mountain bike along an unmade road. He saw Sally, his former girlfriend, walking in the road with her new boyfriend, Tom. Richard was still upset that Sally had left him for Tom. He went past Sally and Tom as fast as he could, deliberately shouting "Boo" as he went past them. Sally was startled by the shout and jumped to the edge of the road where she slipped and fell into a ditch, suffering bruising.

- (a) Criminal liability generally depends on proof of *actus reus* (including causation) and *mens rea*. Briefly explain and illustrate what is meant by these three terms. (15 marks)
- (b) Discuss Richard's criminal liability for the incident involving Sally. (10 marks)

**Tort** 

## Total for this question: 35 marks

Yannick and Zoe, university students, were at a music festival organised by XS Limited. They were sitting on the ground in the main tent, listening to a band, when one of the tent supports became detached and the tent collapsed.

Yannick suffered severe head and neck injuries. He spent many months in hospital and, despite the best efforts of the medical teams, he was paralysed from the neck down.

Zoe was fortunate not to be injured, but spent so much time visiting Yannick in hospital that she failed her exams and had to repeat the year.

- (a) In relation to the law of negligence, discuss whether XS Limited owes a duty of care to Yannick and Zoe. (10 marks)
- (b) Explain how the law decides whether a loss is too **remote** to be recovered. Apply the rules on **remoteness of damage** to the losses suffered by Yannick and Zoe. (15 marks)
- (c) Explain how the court would **calculate** an award of **damages** (compensation) to Yannick.
