2003 ready for the new exams in June 2004.

#### **What are the new exam papers?**

The new exam scheme will consist of 4 papers:

Paper 1: Structure and Operation of the English Legal System (1.5 hours)

Paper 2: Data Response on the English Legal System (1.5 hours)

Paper 3: Law of Contract (1.5 hours)

Paper 4: Law of Tort (1.5 hours)

Papers 1 and 2 make up the AS level.

Papers 1,2,3 and 4 make up the A level.
