TRANSITION BETWEEN THE SPECIFICATIONS

This communication is intended reiterate and reinforce the information provided in the June 2007 **TRANSITION BETWEEN THE SPECIFICATIONS** Notice.

The following table shows how OCR's current GCE Law specifications will be phased out (the '6-unit' specifications (3839/7839) and the current '4-unit' specifications (H124/H524)) and how the new '4-unit' specifications (H134/H534) will be introduced.

Please note that <u>all</u> legacy GCE A-Level A2 units from the current '4-unit' specification (H124/H524) will now also be made available for final re-sit in the June 2010 series. This change is highlighted in the first table.

The new '4-unit' specifications (H134/H534) are being introduced in line with the 14-19 government requirements for all A-Levels. The proposed changes have incorporated stretch and challenge into the specifications and have included a review of synoptic assessment.

The third page of this Notice gives the themes and availability for the Special Study units for each of the three specifications.

To summarise:

- The current '6-unit' Law specifications (3839/7839) have been superseded by the current '4-unit' Law specifications (H124/H524) for first teaching from September 2006.
- Final certification for the current '6-unit' specification will be in January 2008; the final re-sit session.
- The AS units for the current '4-unit' specifications (H124/H524) were offered for the first time in January 2007. The A2 units will be offered for the first time in January 2008.
- Final certification for the current '4-unit' specification (H124/H524) will be in June 2010, with June 2009 being the final AS re-sit session and June 2010 the final A2 re-sit session.
- The AS units for the new '4-unit' specification (H134/H534) will be offered for the first time in January 2009 and the A2 units for the first time in January 2010.
