Mark Scheme

Mark schemes are prepared by the Principal Examiner and considered, together with the relevant questions, by a panel of subject teachers. This mark scheme includes any amendments made at the standardisation meeting attended by all examiners and is the scheme which was used by them in this examination. The standardisation meeting ensures that the mark scheme covers the students' responses to questions and that every examiner understands and applies it in the same correct way. As preparation for the standardisation meeting each examiner analyses a number of students' scripts: alternative answers not already covered by the mark scheme are discussed at the meeting and legislated for. If, after this meeting, examiners encounter unusual answers which have not been discussed at the meeting they are required to refer these to the Principal Examiner.

It must be stressed that a mark scheme is a working document, in many cases further developed and expanded on the basis of students' reactions to a particular paper. Assumptions about future mark schemes on the basis of one year's document should be avoided; whilst the guiding principles of assessment remain constant, details will change, depending on the content of a particular examination paper.

Question 1 The cosmological argument

Explain Aquinas' cosmological argument with particular reference to:

- · God as the first mover
- · God as the necessary being.

Answers should focus on the actual areas listed in the question and how they relate to the cosmological argument rather than a general presentation of the cosmological argument.

Expect reference to the First and Third Way.

First Way – idea of move/change. Illustration of potentiality and actuality. Explanation of a mover that is not itself moved. Rejection of infinite regression.

Aquinas' idea of initiator of change whose continued existence is depended upon. Third Way – idea of contingency and necessity. Nothing would come into existence if everything contingent since everything contingent has a dependency. There must exist a being who is not dependent on any other for its existence.

Maximum level 5 (23) if only one aspect answered.

'The cosmological argument proves that God exists.' How far do you agree?

The focus will be on weighing up the argument in terms of its strength of proof. Possible discussion might include:

Agree

Logic of argument

Argument requires God as explanation (nature of God such as necessary being) Failure of criticisms

Disagree

Success of criticisms
Other possibilities for explanation besides God
Probability rather than proof

An appropriate conclusion should be in terms of 'How far.'

Question 2 Religious experience

0 3 Examine the main characteristics of visions and of mystical experiences.

Focus is on highlighting the characteristics rather than just descriptive accounts. For visions expect characteristics such as an image/event in which there is a message, variety of images (religious figures/places/fantastic creatures/end of world), types of visions (group, individual, corporeal, imaginative).

For mysticism expect characteristics such as ineffability, noetic, transiency, passivity. For depth account expect illustration of characteristics, wide range of characteristics and different types of mysticism (monistic/theistic).

6 4 'Science has fully explained religious experience.' To what extent do you agree?

Possible discussion might include:

Agree

Reference to scientific explanations providing natural explanations (such as drugs, temporal lobe epilepsy)

Stimulating religious experiences (such as Persinger's helmet)

Disagree

Criticisms of those examples from science

Defence of validity of religious experiences (such as group visions)

Not all can be explained by science

Appropriate conclusion will be in terms of 'to what extent they fully explain'.

Question 3 Psychology and religion

0 5 Examine ways in which Freud challenged belief in God.

The focus should be on challenging belief in God by reference to Freud's views of religion. Expect examples to illustrate:

Belief in God as aid to overcoming inner psychological conflict (e.g. collective neurosis/repressed sexual trauma memories/Oedipus complex)

Belief in God as an illusion (e.g. reason to submit to authority)

Belief in God as help to overcome fear of natural forces (e.g. belief that religion can control these forces)

The illustrations need to make clear how 'belief in God' is challenged.

0 6 'Religious

'Religious faith is necessary for good mental health.' How far do you agree?

Expect both Jung and Freud.

Expect Jung's theories to be seen as positive to mental health (such as quest for integration)

Expect Freud's theories to be seen as negative to balanced mental health (such as neurosis). However both link to mental health.

An appropriate conclusion should be in terms of 'how far' (e.g. Freud positive in seeing it as overcoming inner psychological conflicts and fear of natural forces)

Question 4 Atheism and postmodernism

Explain what is meant by:

- 'There is no God'
- 'God is dead'.

There is no God – discussion about meaning of 'atheism'

Expect reference to different types of atheism such as positive and negative atheism.

God is dead – Nietzsche and the madman. God no longer relevant to society. Modern development of this e.g. Honest to God, Sea of Faith and Dawkins.

Maximum level 5 (23) if only one discussed.

'Religion has not responded successfully to the challenge of atheism.' To what extent do you agree?

Expect agreement to claim to include evidence of growing atheism and decline of religion. Atheism more vocal and persuasive.

The counter claim might include responses to atheism and evidence of growing numbers in religions and how religion has refocused.

An appropriate conclusion should be in terms of 'to what extent.' Expect some discussion about degree of failure.
