- 2 (a) Explain the different roles of Jews and Romans in the trial of Jesus. [25]
(b) 'In his account of the trial of Jesus, Mark judges the Jews too harshly.' Discuss. [10]
- 3 (a) Explain how the story of Jesus' appearance on the road to Emmaus shows Luke's understanding of the resurrection. [25]
(b) 'For Luke, faith in the resurrection was more important than fact.' Discuss. [10]
- 4 (a) Explain the relationship between Q and the Synoptic Gospels. [25]
(b) 'Arguing about the sources of the Gospels is pointless.' Discuss. [10]
