Animal Fun Land Staff procedures policy

- 1) If there is a fire at Animal Fun Land, smash the glass on a fire alarm and tell all staff via walkie talkie in case any staff are out of hearing range of the fire bell. Help the public to evacuate the site and report to the office for further instructions.
- 2) If an animal escapes, inform the duty manager, tell all staff via walkie talkie, check all enclosures and report to the office.
- 3) If a member of the public or staff is injured, fill in an accident form from the office and contact the First Aider. File the form in the filing cabinet.
- 4) If there is a death of a small animal put the body in a bin bag and store in the freezer. If there is a death of a large animal, isolate and cover the corpse and contact the fallen stock company to remove.
- 5) If an animal gives birth, make a note of the birth on the animal's record chart.
- 6) If an animal is sick or injured call the vet.
- 7) If there is a power cut evacuate the public as electric fencing may not work.
- 8) If animal housing or fencing is damaged tell staff via walkie talkie to help stop animals escaping.
- 9) Dogs are allowed on-site but all dogs must be kept on leads and under control.
- 10) No smoking on the premises, use designated offsite areas.
- 11) All staff must wear PPE and uniform at all times.
- 12) Appropriate restraint equipment must be used when moving animals around the site.
- 13) All staff must be appropriately trained in animal welfare and health and safety.
- 14) All staff must complete husbandry records indicating what tasks have been completed to ensure animal welfare needs are met.
- 15) All work experience students must be supervised at all times.

Stoneshire Council guidance for zoo/animal collection owners

This guidance is for any zoo that members of the public can visit, with or without charge, for seven days or more per year.

Zoo owners must apply to the local authority for a licence. So it may be inspected, and a licence will be given if these conditions are met.

Stoneshire Council guidelines for animal in zoos or collections

- 1. All zoos must carry out research for conservation.
- 2. All zoos must share information with other zoos.
- 3. All animals, if suitable, must take part in captive breeding programmes.
- 4. All animals must have suitable accommodation and conditions that meets their needs.
- 5. Regular risk assessments must be carried out and these must be recorded.
- 6. All animal housing should meet their physical, psychological and social needs.
- 7. All animals should have good husbandry, preventative care, veterinary care and nutrition, and detailed records of this must be kept.
- 8. All zoos must have procedures in place to prevent the escape of animals and a policy to be followed in the event of escape.
- 9. All zoos must try to prevent pests and vermin.
- 10. All zoos must keep records of:
 - animal numbers
 - acquisitions
 - births
 - deaths
 - disposals
 - any escapes.
