

Shirevale Doggy Day Care staff procedures

On arrival:

- 1. All dogs to be given a thorough health check on arrival.
- 2. All owner contact details to be confirmed on each visit.
- 3. Daily password issued.

Daily care:

- 1. All dogs to be supervised by one member of staff at all times.
- 2. All dogs' equipment to be labelled and only used for that specific dog.

Hygiene procedures:

- 1. All dog waste to be removed as soon as identified via poo bags and placed in specific dog waste bin, all urine to be mopped as soon as possible.
- 2. All dog feeds to be labelled to ensure dogs are given the correct food.
- 3. All areas, including exercise areas and play equipment within them, to be disinfected every week.

Emergency procedures:

- 1. In the case of an ill animal isolate and call the manager.
- 2. In the case of an escaped animal call the manager.
- 3. In the case of a fire, sound the fire alarm and report to the office for instructions from the manager.

Owner collection:

1. Password to be confirmed to ensure the dog is released to the correct owner.



Oakshire Council licensing requirements for establishments carrying out activities involving animals

- 1. Clear and detailed records must be kept about all the animals on the premises.
- 2. The number of animals must be appropriate for the number of staff and the facilities.
- 3. There must be enough competent staff to meet the animals' welfare needs.
- 4. All staff should be able to identify normal behaviour of the animals.
- 5. All staff to recognise signs of pain, suffering, injury, disease and abnormal behaviour.
- 6. All areas must be safe and secure to prevent injury, illness and escape.
- 7. All animals must be kept in suitable conditions for their species including:
 - their behavioural needs
 - space, air quality, cleanliness and temperature
 - noise levels
 - light levels
 - · ventilation levels.
- 8. Animals must not be left unattended when in distress.
- 9. Sick or injured animals must be dealt with promptly and if needed see a vet.
- 10. Self-contained isolation facilities must be available.
- 11. Animals' housing should be cleaned regularly.
- 12. Equipment must be stored in an area safely away from animals preventing injury.
- 13. Cleaning products must be safe, effective and stored in a locked cupboard when not in use.
- 14. Food preparation should be carried out in a clean area.
- 15. A written emergency plan must be in place.

Instructions to Teachers/Tutors
